HOSTEL RULES & REGULATIONS

1. General Hostel for students is a facility provided by the college and **this cannot be claimed as a right**. The management has absolute right to permit or refuse hostel facility to a student without assigning any reason whatsoever.

2. Eradication of Ragging:

While the college encourages all students to mix freely and live and work together in harmony, ragging in any form is strictly forbidden. Any student indulging in ragging will be immediately expelled from the Hostel and will be subject to disciplinary action which may culminate in his/her expulsion from the college as well. It may also be noted that as per the Supreme Court orders ragging in any form is a cognizable offence. It is mandatory and legally binding for the college administration to report each incident of ragging to the Police for taking appropriate action under the Law. Ragging of any junior or fresher student is an offence in accordance with the ruling of country's Apex Court.

3. Management of the College would like its hostellers to consider the hostel as their home. Hostellers must conduct themselves in a manner as they would do in their homes. Students from all parts of the country stay together as brothers/ sisters without any problems in the hostel or in the campus.

4. Facilities:

- f. Internet facility.

5. **Empanelled Hospital:**

Sarvodaya Hospital & Vrindavan Hospital have been empanelled to provide health services to the students staying in hostels.

7. **Admission:**

Students desiring hostel accommodation must apply on prescribed application form duly signed by the Parents by the due date. Incomplete application forms will be rejected. Once application is accepted in principle, the student will then approach the accounts office and deposit the required fee. Duly filled application form to be submitted to the Warden.

Students already staying in the hostel do not get the allotment in the next academic session unless an application is submitted by the current occupant on the prescribed application form.

8. **Registration:**

Only those applicants who have deposited the fee/advance will be registered and name included in the Seniority list which will be prepared based on the date of deposit. Existing hostellers who do not register themselves will lose their preference and treated as fresh applicants for allotment.

9. **Seniority:**

Two seniority lists shall be maintained by the hostel committee.

Old/Senior Students/Residents:

- (a) **List 1:** Old/Senior Students/Residents of the hostel will be given preference. However, old students shall have to apply afresh before the end of the current academic year and shall be registered only on submission of application and after having deposited hostel fee in advance. If student does not deposit fee on the prescribed time, then allocation of hostel to him/her will depend on availability.

(b) **List 2: New/Fresh Students/Applicants**

10. Criteria to be followed for Hostel allotment:

Allotment of rooms in the hostel shall be made on first come first served basis and on academic merit of the students. No request for specific rooms shall be considered. However, request for choice of room-mate may be considered only after approval of the committee. Room once allotted shall not be changed for whatever reason it may be. Hostel Management Committee has laid down following criteria for allotment of room.

- (a) **Priority 1** – Year-wise merit list of the students shall be drawn and rooms allotted strictly as per merit. While preparing the merit list, record of updated and available percentage of marks in the University Examinations shall be taken into account. Cut-off date for preparation of merit list will be taken as 30th April of the preceding academic year. It means that merit list will be prepared only for those students who have registered for hostel accommodation by 30th April. Name of students with any back paper will not be included in the merit list. If the result of even semester (II, IV, VI) has not been declared, hostel accommodation will be done on provisional basis, based on the result up to previous semester. If the allottee fails in the even semester, his allotment will stand cancelled and he has to vacate the hostel within a week of declaration of result.
- (b) **Priority2** – As per merit list prepared for students with only one back paper and so on (if rooms are vacant).
- (c) New students taking admission in the first year shall be allotted hostel accommodation on first come first served basis, except for students residing in Noida, Ghaziabad and Delhi.

NOTE: No hostel accommodation will be allotted to the following

- (a) Students involved in indiscipline cases of any nature in the past.
- (b) Students with any PCP (Back Paper)
- (c) Students whose class attendance was below 75% while staying in the hostel during the preceding academic year.

11. Following are the Hostel and Mess charges per academic year and are to be paid in one lump sum, payment in installments is not permissible:-

- a) Single Seater Room
- b) Double Seater Room
- c) Triple Seater Room
- d) Medical Insurance
- e) Conveyance Charges
- f) Caution Money

NOTE:

- i. Mess charges are received from students by the college on behalf of the mess contractor and paid by the college to the contractor on behalf of the students.*
- ii. Hostel Charges are for total of 10 months in an academic year.*

12. Medical:

- a. Students are compulsorily required to submit a medical certificate from MBBS qualified Registered Doctor. Students are also required to get themselves vaccinated against "Hepatitis B" and must submit a certificate at the time of admission.
- b. In case a boarder becomes seriously ill, his/her parents/guardians are informed by the telephone. If required the student is taken to the Hospital by Ambulance, given treatment or hospitalized for immediate treatment. All expenditures incurred on medical treatment of the student will be realized from parents.
- c. Qualified doctors are available at the medical room situated in the College campus/Hostel.

13. Code of Conduct:

Hostellers will follow and strictly adhere to the rules prescribed by the Hostel management. Non – adherence to the rules will invite expulsion from the hostel.

14. Damages:

Items issued to hostlers in the room shall be checked by the warden before the students vacate the rooms at the end of the year. Students shall be required to pay for any damages caused to the items issued or the fixtures.

15. Instructions for Hostellers Do's:-

- a. Maintain strict discipline at all times and obey all written/verbal instruction issued from time to time.
- b. Read the notices on the notice board daily and follow instruction. Ignorance of orders/instructions will not be accepted as an excuse.
- c. Keep their rooms and surroundings clean.
- d. Switch off the lights, AC and fans and lock the room before leaving.
- e. Gate pass is a must while proceeding home even when college closes for holidays/semester breaks or going out for even one night during academic days.
- f. Enter in register while leaving hostel for shorter period and also show their I-cards at gate while going out of college or entering the college.
- g. Make an entry in the register kept with the Security before proceeding to town on a visit or to their homes.
- h. Return back to the hostel in time as notified from time to time.

- i. Report to the Hostel Warden in case of sickness of any other hostel inmate.
- j. Immediately report to Chief Warden/Warden/Security in case of damage noticed.
- k. Make use of facilities strictly as per laid down timings.
- l. Strictly follow meal times as laid down from time to time.
- m. Dispose of the waste in the dustbins provided for this purpose only.
- n. Ensure safety of items/equipments provided in the hostel or mess.
- o. Make payment to washer man immediately on receipt of washed/ironed clothes as per laid down rates (students shall give clothes to the washer man at their own risk.)
- p. Shall use bathroom or toilet fittings properly and shall not damage these.
- q. Avoid wastage of water and close the water taps immediately after use.
- r. Proper dress code (casual dress) for girl students should be adhered during their stay in hostel after college hours.

- 16.** It is obligatory for every resident student to seek Chief Warden/Warden's permission in the form of gate pass for leaving station during the Period College is functioning. Gate pass must be shown to the Security Staff while going out from or returning to the campus. Residents student must observe the following timing to sign their Gate Passes:

17. Hostel attendance Timings :

Boy's Hostel:

9:30 pm to 10:30 pm or as notified by the Chief Warden as per the season.

Girl's Hostel:

6:30 pm to 7:30 pm or as notified by the Chief Warden as per the season

- a) Students will have to vacate their rooms within two days after their examinations are over.
- b) Students should carry hostler identity cards while moving in/out and from/to campus/hostel.
- c) Students, if desire, may celebrate any function (Birthday etc.) in the dining hall between 4:30 pm to 5:30 pm (at tea time) or in the college canteen before 8 pm with permission from warden. In any circumstances, students will not celebrate any function in any their rooms.

Important Note: - After college and hostel attendance timings no one is allowed to leave the hostel premises without taking prior permission from warden followed by gate pass and entering at the

hostel and college registers maintained by the college guards. If any student does so, he/she will be held responsible for any mishappening.

18. Instructions for Hostellers Don'ts:-

- a. Stay in their hostel rooms during the academic hours.
- b. Leave the premises without permission.
- c. Usage of heaters or Immersion rod or electric press, is not allowed. If found using these items, these will be confiscated and a fine of Rs 500/- for the first time and there after Rs. 1000/- will be imposed as per rules and he/she will be liable for expulsion from hostel if found using the above items second time.
- d. Take any visitor, relatives and friends, outside student or day scholar to the hostel.
- e. Bring any item of mess such as food, plate, tumbler or spoon to their rooms from the mess.
- f. Leave the room unlocked or unattended. **College authorities takes no responsibility for any losses.**
- g. Remove furniture or any other item from other rooms.
- h. Keep any valuable or cash in the room. **College authorities takes no responsibility for any losses.**
- i. Cook any type of meal in the room.
- j. Play loudly any transistor or music.
- k. Disturb other students in the hostel.
- l. Play cards or gamble or any other undesirable act, in the room.
- m. Chew pan, tobacco, gutka or smoke bidi/ cigarette in the hostel/ campus.
- n. Students are strictly forbidden from consuming alcohol, drugs, cigarette, tobacco products or any other intoxicants inside the campus or to enter the campus after consuming the same. Any student found consuming such things or in a drunken state in the campus will render himself/herself liable for strict disciplinary action, including expulsion/rustication from Hostel/College.
- o. Bring any food to the room from the mess unless permitted to do so in case of sickness etc.
- p. Keep the computer in the room without written permission from the Director. College authorities shall not be responsible for any loss or damage even if the permission is granted.
- q. Keep the hostel telephone engaged for more than 3 minutes.
- r. Get involved in the ragging of fresher's. Defaulters shall invite expulsion from the hostel or even college. Ragging of fresher's is an offence and punishable in accordance with the ruling of country's Apex Court.
- s. Students are strictly forbidden to keep any kind of firearms (even if it is a licensed one), fireworks or weapon (knife etc.) in the campus.
- t. Play Holi with colour, water or mud and burst crackers in the hostel premises during Holi & Diwali respectively.

- u. Park the two-wheelers in the Hostel Campus without necessary permission.
- v. Allow or permit day scholars inside their rooms.
- w. Students of opposite sex are NOT permitted to enter the Hostel/Mess.
- x. Misuse of electricity by the hostler will be fined Rs.200/- for the first time and Rs. 500/- for the second time and thereof.

19. Expulsion from the Hostel & Mess:

In case the College authorities is of opinion that the conduct of the student is not up to the mark as is expected, the student shall be immediately expelled from Hostel and disciplinary action will be initiated.

20. Rules for refund will be as under:-

20.1 Rules for Odd Semester:

In case of:

- Expulsion from the Hostel, only remaining mess chargers to be refunded to the student.
- Student who leave Hostel on their own with due permission from college authority; only one semester lodging charges and remaining mess charges to be refunded to the student.

20.2 Rules for Even Semester:

In case of:

- Expulsion from the Hostel only remaining mess charges to be refunded to the student
- Students who leave Hostel on their own with due permission from college authority; only reaming mess fess will be refunded to the student.

20.3 Rules for late Admission to the Hostel:

- Students who join the Hostel late, with due permission from Hostel Allotment Committee, Student have to pay Hostel fees from the month of joining the Hostel.
- Hosteller(s) willing to become day Scholar(s) have to apply in prescribed format to Registrar.

21. Hostel Fee structure for the session 2019-20 :

We wish to inform that those students who are desirous to avail Hostel facility in the session 2019-20 may contact wardens for availability of accommodations single, double, triple or four seated rooms. The hostel charges for the session 2019-20 per students shall be as under:

22. Hostel Mess Rules:

Mess facility to the students is provided by the mess contractor with the consent of mess committee comprising of the hostlers on behalf of the students. Mess committee is responsible for the quality and hygienic conditions of the food which is served to the hostel inmates. The college is only responsible to make payment on behalf of the students to the mess contractor.

Breakfast, Lunch, evening Tea & snacks and Dinner will be provided in the mess at stipulated time. Mess will be closed during Holi/ Diwali holidays and Summer/Winter vacation & **NO REFUNDS ARE PERMISSIBLE.**

Mess timings for Working Days:

Morning breakfast	: 07:30 am – 08:30 am
Lunch	: 12:00 pm – 02:00 pm
Evening snacks	: 05:00 pm – 06:00 pm
Dinner	: 07:30 pm – 09:00 pm

Mess timings for Sunday / Holiday:

Morning breakfast	: 08:00 am – 09:15 am
Lunch	: 12:30 pm – 02:15 pm
Evening snacks	: 05:00 pm – 06:00 pm (Excluding Sunday)
Dinner	: 07:30 pm – 09:00 pm

Following norms shall be strictly adhered to:-

- No utensils are allowed to be taken from mess. Defaulters will be fined Rs. 500/-.
- If any Hostler allows a day scholar to stay in his room, he will be fined Rs. 1000/- & his allotment will be cancelled. The concerned day-scholar will also be fined Rs. 1000/-.
- Drinking liquor in hostel campus is strictly prohibited. Anyone found indulging in drinking will be expelled from the hostel along with fine of Rs. 8000/-. He may also expelled/rusticated from college after proper enquiry by Proctor.
- No mess off are allowed for whatsoever reason it may be.
- Students will maintain discipline at meal timings and follow normal mess manners.
- Students shall form and follow a queue at the place of distribution of food.
- Hostlers are expected to follow table manners.
- Students are not allowed to enter the kitchen/cooking area.
- Students will not get into an argument with mess staff/ contractor for any reason whatsoever.
- Complaints if any are to be reported to the Warden/Chief Warden.
