INTRODUCTION

BRIEF HISTORY:

Guru Ravidas Ayurved University Punjab, Hoshiarpur was created with the promulgation of the Guru Ravidas Ayurved University Punjab Act, 2009 (Punjab Act No. 4 of 2010) by the Punjab Legislative Assembly. This University regulates the conduct of both undergraduate and post-graduate Ayurvedic, Homeopathic and Unani teaching in 21 affiliated colleges in the State of Punjab. It has about 6,000 registered students presently undergoing undergraduate and postgraduate studies in various disciplines.

UNIVERSITY'S PRESENT STATUS:

This University is one of its own kinds in North India. It is presently poised for a quantum leap in development and progress. The foundation stone of University campus was laid on 09.10.2011 by Sardar Parkash Singh Ji Badal, Hon'ble Chief Minister of Punjab and the administrative Block of University Campus in Village Kharkan, Near Hoshiarpur and just 10 km from Hoshiarpur city was inaugurated by Sh Vijay Sampla, Hon'ble Minister of State, Social Justice and Social Welfare, Government of India on 19.04.2016. It will bring about major development in AYUSH and all basic, clinical and allied departments to pursue on education and research. It will attract appropriate talent from all over the country to work in its faculties. It will shortly start new AYUSH courses.

University Examination System:

The University had introduced e-transfer system of question papers of various courses to the examination centers to maintain the sanctity of examinations. This process and implementation strategies will help us to deliver, efficiency, reliability in high stakes examination and their certifications.

Guru Ravidas Ayurved University Punjab Hoshiarpur

Ph.D. Regulations

1. Minimum Qualification For Enrolment:-

(a) Must possess a MD (Ayurveda)/MS (Ayurveda) from a recognized University and approved by CCIM.

OR

- (b) M.Sc. Chemistry, M.Sc. Botany and Post Graduation in any medical stream from a recognized University.
- (c) Entrance Exam is compulsory for all the applicants. Preference will be given to Ayurvedic Teachers + Research experience holders.

2. Tenure for the Ph.D Degree:-

A minimum of 3 years and maximum of 6 years shall be given to candidate to complete the Ph.D. The registration shall be treated as cancelled automatically after 6 years. One mercy chance may be allowed for genuine reasons with the permission of Hon'ble Vice Chancellor. 30 days attendance every six months is mandatory with the guide as contact period.

3. Ph.D. Registration Committees/Ethical Committee:-

The research committee consists of the following:-

Dean Colleges -Chairman
Dean (Concerned Faculty) -Member
Controller of Examinations -Member

3. Subject Expert - Within State or outside state one (Nominated by VC)

4. Procedure for the admission:-

(a) The admission in Ph.D. course will be done only once every year.

- (b) A list of available guides along with vacancies under them will be displayed at the time of admission.
- (c) The students appearing in the Final Year Examination for M.D./M.S. (Ayurveda) can also apply for registration. However their registration will be subject to their passing in the M.D./M.S. (Ayurveda) examinations before the admission process.
- (d) The guides will be allotted to the candidates on the basis of their merit, their choice for the guide and availability of the seats under the guides and acceptance of guide.
- (e) Post Graduate candidates in any stream of Ayurved/Medical can apply in any of the subject offered by the University.
- (f) NOC is mandatory for all the Government, Aided, Autonomous/ Private Institutions teachers/employees from their departments.
- (g) Prescribed University fee is mandatory for all the candidates.

5. Fee Structure:-

7. Guides Ratio:-

There should not be more than 4 candidates under a Professor, 3 candidates under a Associate Professor and 2 candidate under a Assistant Professor in a department. Above prescribed quota shall automatically be considered vacated at the end of one year from the date of registration.

Professor - 4 students.
Associate Professor - 3 students.
Assistant Profssor - 2 students.

8. Research Project:-

It is mandatory that candidate should complete his/her research work under the supervision/guidance of his/her Guide at the place where guide is posted. Under job candidates must select a co-guide to do his research work with the permission/consent of his Guide.

9. Submission of synopsis:

Candidates will submit the synopsis of research project under the guide and will submit the same with approval of guide within three months of allotment of guide.

10. Submission of half-yearly progress reports and evaluation of course work:

After provisional registration, every candidate shall submit the half yearly progress reports regularly as desired by the university in the prescribed format through the Guide to the Registrar of the University. The candidate can seek guidance for preparing half-yearly reports, pre submission report from the Guide. The half yearly progress report will be assessed by the University nominated experts and comments/observations will be communicated to the concerned candidate and Guide. On non-receipt of progress report, a fine of Rs. 500/- per week may be charged

from the candidate for every delayed progress report, or as decided by the University Authorities.

If two consecutive half-yearly progress reports are not satisfactory, the Ph.D. Registration committee of the University may recommend to the University for Cancellation of the registration of the respective candidate.

11. Submission of the Thesis:-

Upon satisfactory completion of the course work, a student registered for Ph.D. will be required to submit a thesis. Before submission of thesis for the award of Ph.D. degree, the candidate should publish his research findings in the form of two research papers in scientific journals. Reproduce these two research papers should be incorporated in the Ph.D. thesis or proof of research papers having been accepted for publication in the journals.

- i) The thesis shall be submitted by the student to his/her Guide between 15 to 90 days of the presubmission seminar.
- ii) The research student shall submit a soft copy and 5 hard copies of the summary of the thesis (3000-5000 words) to his/her Guide at least 45 days before the submission of thesis. The Guide shall forward it along with the list of evaluators of the thesis, to the University. The University shall process the case for nomination of evaluators after receiving the synopsis and list of evaluators.
- iii) Four hard copies of thesis (which should be at least of 200 pages with clear readable fine printing) with brown thesis cover along with soft copy shall be submitted to the University through the Guide in the following format:
 - a) The paper used for printing shall be A4 size.
 - b) Typed/word processed on both side of the papers in one and half-space.
 - c) Font size: 12 point in Times New Roman or Calibri font type, Hindi Font Size 14.
 - d) Margin 1.25 inch from all four sides.
 - e) The cover page of the thesis should display:

- i) The title of the thesis.
- ii) Name of the University.
- iii) Degree, its specialty and department.
- iv) Name of the Guide and Co-Guide if any.
- v) Month and year of the submission.
- vi) Registration number.
- iv) The Thesis shall include a declaration by the candidate that the work reported in thesis is original and carried out by the candidate himself/herself and that the material from other sources, if any, are duly acknowledged. The format of the certificate has been provided in the brochure.
- v) The Thesis shall also include a certificate signed by the Guide about the originality of the work and successful completion of the Course Work. The format of the certificate has been provided in the brochure.

12. Evaluation of Thesis

The thesis shall be examined by the Guide and two external experts nominated by the University from the panel of experts proposed by the Guide. In case the Vice Chancellor feels that the panel contains the repetition of the names of external experts or are not appropriate, he/she may nominate other external experts for the evaluation process.

All efforts should be made so as to complete the entire process of the evaluation of Ph.D. thesis within a period of three months from the date of submission of the thesis.

In case any examiner suggests certain modifications in writing or re-submission of the thesis, the same should be communicated in writing to the candidate, who will be asked to resubmit the thesis with all the modifications within time period as given by the University. The Guide will ensure that the suggestions of the examiner are adequately addressed before resubmission of the thesis. The modified thesis shall be referred again to the examiner concerned for re-evaluation.

If one of the external examiners does not recommend the thesis for the award of a Ph.D. degree, the thesis shall be referred to another examiner for independent evaluation. If the third external examiner recommends the thesis for the award, the viva voce examination shall be organized. However, if this examiner also rejects the thesis, the thesis shall be deemed to be rejected by the University.

The examiners' reports will be communicated to the Guide to be shared with the candidate prior to the viva-voce examination to enable her/him to address the issues raised therein while preparing to defend the thesis.

The viva voce examination shall be conducted at Guru Ravidas Ayurved University Punjab Hoshiarpur as an open defense of the thesis by a panel comprising of one of the external examiners nominated by the Vice-Chancellor and Guide of the candidate. The Registrar/Controller of Examinations/Dean Colleges shall be the Chairperson of the panel. The date for open defense, venue, and topic of the thesis with a brief abstract shall be communicated to the candidate and Guide.

13. Award of the Ph.D. Degree

- i) The report of the viva voce examination prepared by the External Examiner and the Guide will be sent to the University. The report shall be placed before the Vice Chancellor for approval and award of the Degree.
- ii) The University will communicate the approval of the Hon'ble Vice-Chancellor along with evaluation reports and joint report of the viva-voce examination to the Degree Section for issuance of the Degree and Notification.
- iii) The Ph.D degree will be awarded to the successful candidates by the University.
