Maulana Azad Institute of Dental Sciences is Premier Institution in the field of Dental Sciences in India which has been declared "Centre of Excellence" by the Govt. of NCT of Delhi.

1. Major activities and achievements

The Institute is catering an average of 1317 Patients/day with 216 Implants and 2379 prosthesis per month. In Continuation of the institute's mission of providing quality services to citizens, it has been again accredited by NABH for a span of three years till 2017, which is the first Dental Institute to do so in India. A lone and one of its kinds in India is the Mobile Dental Project in collaboration with NHM having 6 mobile dental units catering the North East and West Delhi Dispensaries. Till now it has catered 31,569 patients this year and 16951 treated free of cost. ## 7. Any other significant information (Paragraph format)

The Phase II building of MAIDS has been started with new research facilities and competitive quality equipments. New facilities of Tissue bank and TMJ clinic which are both one of its kind in India has been instituted. The introduction of new comic characters "BABLOO & RANI" and series for IEC for school children by Department of Public Health Dentistry was done for the benefit of school children. ASHAKIRAN HOME for mentally disabled is one of the largest in Asia and interdisciplinary efforts are going on to improve the oral health of inmates by providing preventive and curative services. Training of care takers and nurses has been initiated as part of oral health promotion. The institute played a major role in oral health and oral cancer screening in NCD, screening & awareness camps at Pragaiti Maidan from 14<sup>th</sup> -27<sup>th</sup> November 2015 at 35<sup>th</sup> India International Trade fair. First ever dental check up and treatment camp was organised by MAIDS in the Supreme Court, Delhi with the gracious presence of Honorable Chief Justice of India, Mr. S.K Dattu on Saturdays on 10th, 17th and 31st January, 2015. A .stal of 402 employees of Supreme Court were screened and 11% of them were treated for some or the other ailments.
