

1.0 INTRODUCTION

National Institute of Technology Delhi (NITD) is one of the ten new NIT(s) established in the year 2010 by an act of parliament and has been declared as an Institute of National importance. NIT Delhi is an autonomous Institute which functions under the aegis of Ministry of Human Resource Development, Government of India. It aims to provide instructions and research facilities in various disciplines of Engineering, Science and Technology, Management, Social Sciences and Humanities for advanced learning and dissemination of knowledge.

The mission of NIT Delhi is to produce human resource those who are creative, competitive and innovative with high intellect and ethical values. The Institute is imparting holistic education, along with inculcating high moral values to its students.

Possession of fifty one acre land along with assignment of NBCc as construction agency has been done. Thereafter, NBCC has completed the construction of Boundary wall. Laying of Foundation stone to start the work for mini campus is proposed in December 2016, So that the construction of first phase of campus can start from January 2017.

2.0 OVERVIEW

Historical Background

National Institute of Technology Delhi (NITD) is one of the ten new NIT(s) established in the year 2010 by an act of parliament and has been declared as an Institute of National importance. NIT Delhi is an autonomous Institute which functions under the aegis of Ministry of Human Resource Development, Government of India. It aims to provide instructions and research facilities in various disciplines of Engineering, Science and Technology, Management, Social Sciences and Humanities for advance learning and dissemination of knowledge.

NIT Delhi has started its initial academic session in 2010 of NIT Warangal with three undergraduate B.Tech degree programmes in Computer Science and Engineering, Electronics and Communication Engineering & Electrical and Electronics Engineering. Later it moved to a temporary campus at Dwarka, New Delhi in June 2012 and now currently running at NILERD Campus, Narela (since February 2014).

Possession of fifty-one-acre land along with assignment of construction has been given to NBCC Ltd. Thereafter, NBCC has completed the construction of Boundary wall. Laying of Foundation stone to start the work for mini campus is proposed in December 2016, So that the construction of first phase of campus can start from January 2017.

Academic Programmes underway at NIT Delhi:

NIT Delhi's first undergraduate batch started as bachelor of Engineering with three branches of Engineering as:

Computer Science & Engineering (CSE), Electronics & Communications Engineering (ECE) and Electrical & Electronics Engineering (EEE) with 30 students in each.

From academic year 2013-14 the intake in each B. Tech programme has been increased to strength of 60 students. M.Tech programme in the discipline of

Electronics and Communication Engineering with an intake of 15 students was introduced from the academic year 2013-14 followed by Ph.D. programme which has started from January 2014. M.Tech Programme in Computer Science and Engineering (Analytics) with an intake of 15 students has been started in Academic year 2014-15. M.Tech Programme in Mechanical Engineering with specialization in CAD/CAM with an intake of 15 students is going to start from Academic year 2016-17.

Admission for B.Tech programmes are made on the basis of the performance in the Joint Entrance Examination (JEE) for the Indian Nationals. Admissions to 50% of the seats are made amongst the students of Delhi & Chandigarh and the remaining 50% seats are made on the basis of all India ranking of the aspiring applicants.

Admissions to the M.Tech Programmes are made on the basis of performance in GATE (Graduate Aptitude Test in Engineering) exam followed by CCMT counseling.

While, Admission to Ph.D. Programme are done twice in a year on the basis of written entrance exam conducted by respective department followed by Personal interview.

2.1 LOCATION

National Institute of Technology Delhi is being run from its transit campus located in Narela sub-city of North-west Delhi district of NCT. It is well connect by rail, road. Nearest Metro station is Jahangirpuri (16.2 kms) on yellow line of Delhi Metro rail system, whereas the airport is located at distance of 38.2 kms nearly 1 hour by road.

The location has good living environment with nearby market where almost all the basic amenities are easily available namely mother dairy, Reliance store, Vishal store, etc



2.2 CAMPUS

The Institute campus is spread over an area of 13 acres on picturesque landscape. It is a harmonious mix of natural beauty with state of art architecture. The campus is not fully residential, consisting of 06 staff quarters. Two hostel for boys are available one at SRHCH and another at TDI Kundli. Girl students have been accommodated in rented hostel at YWCA Rohini & PG hostel has been recently developed with in the campus. The campus is self-contained having shopping booth, ATM, Students Activity Center and Guest House.

2.3 STATUS OF PERMANENT CAMPUS

NIT Delhi has received the possession of land for construction and development of its permanent campus at Narela sub city. The construction of boundary wall has been completed and the process of constructing the mini campus is going to be started soon.

The project has planned to set up academic, residential and sports zones at the site situated at FA-7, ZONE P1 (Narela Sub city), New Delhi, India, shall include Academic blocks, Administration block, Learning centre, Mini campus, Auditorium block, Sports Complex, Hostels, Residential



blocks, Club, Guest House, Director villa, Restaurant with swimming pool, Football ground, Athletic track, Tennis court, Badminton court, Basketball court, Swimming pool etc. with open air theatre and landscaping.

Site Location

Site of proposed project is 208302.85 sq.mt (51.473 acre). The site is connected with two 100 m wide roads, one is GT Karnal Road and other is touching southwest site boundary. The site is enclosed with 50m buffer zone on North West side, 40m buffer zone on south west side and rest site has 20 m wide buffer zone

2.4 ADMINISTRATION

National Institute of Technology, Delhi is an autonomous Institution under the aegis of Ministry of Human Resource Development. The institute functions under the overall control and guidance of the Board of Governors, the other authorities of the institute are the Finance Committee, Building and Works Committee and the Senate. The constitution of the Board of Governors, Finance Committee, Building Works and other Committees are given in section 8. The administration of various Departments/Centres in the Institute is looked after by respective Head of the Departments.

2.7 COURSES OFFERED

Undergraduate Programmes

The Institute offers four-year bachelor degree programmes in following departments of Engineering:

- *Computer Science and Engineering (CSE)*
- *Electronics and Communication Engineering (ECE)*
- *Electrical and Electronics Engineering (EEE)*

The intake of students in each of its undergraduate programme is 60, and Seat In addition, 15% seats are reserved for DASA candidates through SAT conducted by MHRD.

Post-Graduate Programme

The Institute offers two-year master degree programmes in following departments of engineering:

- Electronics and Communication Engineering
- Computer Science & Engineering (Analytics)

The intake of students to these postgraduate programmes is 15 each.

Doctorate Programmes

The Institute offers Doctorate of Philosophy (Ph.D.) degree programme in following fields of Engineering and Applied Sciences:

- Computer Science and Engineering
- Electronics and Communication Engineering
- Electrical and Electronics Engineering
- Chemistry
- Physics
- Mathematics
- Mechanical
- Humanities and Management

2.8 ADMISSION PROCEDURE

Under Graduate Programme

Admission for the B. Tech. Programmes is made on the basis of the performance in the JEE for the Indian Nationals and under the DASA scheme for the NRIs following the guidelines of CCB (Central Counseling Board). The CCB works under the directions from Government of India, MHRD and with full co-operation from National Informatics Centre (NIC), CBSE, and participating Institutions (PIs). The rules and regulations for the admission change from time to time. The main stages in the procedure are conducting the entrance test (JEE), conducting on-line counseling, followed by reporting in allotted Institute and admission.

Post Graduate Programme

The admissions to the M.Tech is provided through CCMT. The idea behind the Centralized Counseling for M.Tech/M. Plan is to accord convenience to the students under one platform for the admissions to the M.Tech programmes at the participating institutes.

Eligibility Criteria

CCMT allows eligible students with valid GATE scores to apply for counseling through a common platform for the M.Tech programmes at the NITs and other centrally funded institutes. Based on the GATE scores of the candidates and the choices filled in by them during option entry.

PhD Programme

Advertisement for admission to the Ph.D. programme is published on the website/newspapers (two times in a year) in the month of April for the first semester (that starts in July) of the academic year and in the month of October for the second semester (that starts in January) of the academic year depending upon the vacancy in the department/centre and availability of research supervisor(s). The advertisement may/may not include the predetermined seats and as per the guidelines of



reservation policy of Government of India. A candidate interested in applying in more than one department/category shall be required to submit separate application forms along with prescribed fees and documents. The candidate shall be required to submit a write-up (1-2 pages) of his/her proposed area of research along with the application form.

Minimum Educational Qualifications for Admission:

Ph.D. in Engineering Discipline:

Master's Degree in Engineering/Technology in the relevant area of research along with Bachelor's Degree in appropriate branch of Engineering/Technology with a minimum of 60% marks or equivalent Cumulative Grade Point Average (CGPA) at Post Graduate and/or Bachelor's levels.

Ph.D. in Sciences:

Master's Degree in appropriate branch of Science with a minimum of 60% marks or equivalent CGPA at Master's and/or Bachelor's levels. Candidates meeting this requirement must also have GATE score/CSIR/UGC/NBHM award/fellowship.

Ph.D. in Humanities/Management:

Master's Degree in appropriate branch of Humanities/Social Sciences/ Management with a minimum of 60% marks or equivalent CGPA at Master's and/or Bachelor's levels. Candidates meeting this requirement must also have UGC award/fellowship.

Note:

- i. A candidate who has obtained research scholarship on the basis of GATE score/ CSIR/ UGC/ NBHM fellowship will also have to qualify the Institute written test and interview for admission to Ph.D. programme.
- ii. 60% is equivalent to CGPA of 6.5 in 10 point scale and 55% is equivalent to CGPA of 6.0 in 10 point scale.
- iii. Relaxation in minimum Percentage/Equivalent Grade Point requirements will be given as per the National Reservation Policy of Govt. of India.
- iv. If a candidate has both M.Sc. and M.Tech degrees then she/he may be exempted from the requirement of NET.

Screening Committee:

A Screening Committee comprises of the Head of Department (HoD) and three faculty members holding Ph.D. degree and a member holding Ph.D. degree from the collaborative organizations/industries/institutes(Indian/Foreign) having MoU with NITD. The committee screens all applications for admission to Ph.D. programme. The committee verifies the eligibility of the applicant(s) for the programme/Entrance Test based upon his/her details mentioned in the application(s) and the documents enclosed.

Entrance Test

All the eligible candidates shall be required to appear in a National Level Written Test to be organized by NIT Delhi. The written Test may be of Multiple Choice Question (MCQ) Mode. A candidate securing atleast 40% marks in the Entrance test shall be declared qualified in the test. The syllabus for the written test will be the same as the latest GATE/NET syllabus in related branch of Engineering/ Technology/ Science/ Humanities.

Interview

The eligible candidates who have qualified the Entrance test are called for the interview. At the time of interview, candidates are expected to discuss their research interest/area of interest.

Interview Committee

The eligible candidates who have qualified the written Test shall be called for the interview. At the time of interview, candidates may be asked to discuss their research interest/area in the form of presentation.

After the interview, the committee recommends the name of candidates found suitable for admission to Ph.D. Programme for the approval of Chairman, Senate. The Deputy/Assistant Registrar notifies the list of selected candidates through appropriate means.

The candidates are advised to check the NIT Delhi website and their email regularly to know their status.

2.10 EXAMINATION & EVALUATION (GRADING SYSTEM)

- As a measure of student's performance, a 7-scale grading system using the following letter grades and corresponding grade points per credit is following:

- A Semester Grade Point Average (SGPA) will be computed for each semester. The SGPA is calculated as follows:

$$SGPA = \frac{\sum C_i GP_i}{\sum C_i}$$

where, C_i = Credit for the course

GP_i = the grade point obtained for the course

n = Number of subjects registered in the semester.

- Starting from I year II semester a cumulative Grade Point Average (CGPA) will be computed for every student at the end of every semester. The CGPA would give the Cumulative performance of the student from first semester up to the end of the semester to which it refers and calculated as follows:

$$CGPA = \frac{\sum S_i C_i}{\sum C_i}$$

where, n = the total number of Semesters under consideration

C_i = Total number of credits registered during a particular semester

S_i = SGPA of the semester

2.11 DEGREE REQUIREMENTS

The requirements for a student to B.Tech Degree program are as follows:

- Credit requirements: Minimum earned credit requirements for the award of degree is 190 (175 for batch 2015 onwards) with a CGPA of not less than 5.0
- The minimum duration for a student for complying with the degree requirement is four academic years from the date of first registration for his/ her first semester.
- Maximum duration for a student for complying with the degree requirement is eight academic years from the date of first registration for his/her first semester.

2.12 PLACEMENT

Placement of B.Tech Batch (2012-2016 batch)

Campus Interviews were arranged for the final year B.Tech students. A handsome number of reputed Industrial houses in the country visited the Institution and selected/short listed the final year students as Engineers. Some of the Companies invited the students to their Corporate Offices for the interviews. (Details are provided under section 6.0).



2.13 GAMES & SPORTS

The students entering in the Institute are required to undergo the following non-credit mandatory requirements towards completion of their degree. The students have to opt for one of these activities based on the enrolment procedure and their choice. A total of 100 hours of prescribed activities are to be completed after registration in the first year. In case the requirements are not met in the first year, the same shall be completed in the second year i.e. end of the 4th Semester. If a student does not obtain a satisfactory grade in the respective registered course within the first two years of his/her stay at the Institute, he/she will not be registered for the higher semester after second year.

The students will be satisfactorily allowed to register in sports activities of the institute as detailed in section 5.

4.4 RULES & REGULATIONS OF B.TECH PROGRAMMES

4.4.1 Registration

Batch 2010 and 2011

- Every student of the B.Tech Courses are required to be present and register at the commencement of each semester on the day fixed for and notified in the Academic calendar.
- Registration for all courses in the first two semesters is organized centrally.
- From the third semester onwards, the registration will be organized departmentally under the supervision of the Head of the Department.
- A student, who does not register on the day announced for the purpose may be permitted, in consideration of any compelling reason, late registration within the next three working days on payment of a prevalent additional late fee as prescribed by the Institute. Normally no late registration shall be permitted after the third working day from the scheduled date.



- Only those students will be permitted to register who have:
 - Cleared all the Institute and Hostel dues of the previous semesters.
 - Paid all required prescribed fees for the current semester, and
 - Not been debarred from registering for a specified period on disciplinary or any other ground.

Batch 2012-2013 and Onwards

- Every student is required to be present and register at the commencement of each semester on the day(s) fixed for and notified in the Academic calendar.
- Percentage attendance for all students will be counted from the date of commencement of the semester, irrespective of his/her date of registration. However, in case of I Year I Semester, attendance will be counted from date of admission into the Institute or date of commencement of class work, whichever is later.
- Registration for all courses in the first two semesters is organized centrally.
- From the third semester onwards, the registration will be organized departmentally under the supervision of the Head of the Department.
- A Student who does not register on the day announced for the purposed may be permitted, in consideration of any compelling reason, late registration within the next week on payment of additional late fee as prescribed by the Institute from time to time. Normally no late registration shall be permitted after one week from the scheduled date.
- After registration in each semester, each student should collect a registration sheet, which indicates the courses registered by him/her in that semester, signed by the faculty advisor. The student should carry this registration sheet for all the examination in that semester. This sheet serves the purpose of hall ticket for appearing for the examinations in that semester.
- If a student finds his/her load heavy in any semester, or for any other valid reason, he/she can drop some courses within three weeks from the commencement of the class work in the semester with the written approval of his/her Faculty Advisor and Head of the department, with and intimation to Dean-Academics.
- Only those students will be permitted to register who have:
 - i. Cleared all the Institute and Hostels dues of the previous semester.
 - ii. Paid all required fees for the current semester, and
 - iii. Not been debarred from registering for the specified period on disciplinary or any other ground.

A student can register for a backlog subject either for (i) Study or for (ii) Examination. In case of study his/her previous marks/grades are cancelled and will have to attend all classes and examinations along with next Batch of students. Major changes in the time-table shall not be entertained to accommodate backlog students. In case of registration for examination, he/she need not attend the classes, but will appear only for the end-semester examinations or make-up examinations as and when they are conducted. In such a case, the student shall be awarded only P Grade, if he/she gets 30% or more marks in the End Semester/Makeup examination. Backlog students registering for Study or Examinations have to submit an undertaking that they will not change the status of their registration in the subject during the Semester.

Batch 2015 Onwards

Registration is an important procedure of the academic system. The registration procedure ensures that the student's name is on the roll list of each course that he/she wants to study. No credit is given if the student attends a course for which he/she has not registered.

- Every student must be present in person and register at the commencement of each semester on the



day(s) fixed for and notified in the Academic calendar.

- Registration for all courses is organized centrally by the academics office in accordance with the respective departments.
- After registration in each semester, each student should collect a duplicate copy of the registration form, which indicates the courses registered by him/her in that semester, verified and signed by concerned authority.
- Registration by a student confirms his/her status as a student at the Institute. Failure to register before the last date for late registration will imply that the student has discontinued studies and his/her name will be struck-off the rolls.
- Every registered student is considered as a full-time student at the institute. They are expected to be present at the Institute and devote full time to academics.
- A student must register a fresh course in study mode only. In case of backlog with F or I grade the student has the option to register either in study or examination mode.
- In case, a student registers a course in study mode, he must fulfill all the attendance requirements and he/she will be evaluated for continuous evaluation, mid semester examination and end semester examination (as per assessment of academic performance given in Section 11).
- In case, a student registers a course in examination mode, there will be no attendance requirement and the student is eligible for end semester examination only. In such cases, student securing 30% or more marks in end semester examination shall be awarded only 'D' grade otherwise 'F' grade will be awarded.

4.4.2 Promotion Rules

Batch 2010 and 2011

There is no restriction for promotion from odd semester to even semester.

- From I year to II year: To be able to register in the second year, a student should have completed at least 30 credits at the end of first year (in first and second semesters put together).
- From II Year to III year: For promotion to V semester, a student should have completed at least 30 credits in III and IV semesters put together and should have cleared all the course work requirements of I year.
- From III year to IV year: For promotion to VII semester a student should have completed at least 30 credits in V and VI semesters put together and should have cleared all the core courses of II year.

Batch 2012-2013 and Onwards

There are no restrictions for promotion from odd semester to even semester.

- From I Year to II Year: To be able to register in the Second Year I Semester, a student should have completed with P or better grade, at least 30 credits at the end of first year (in first and second semesters and make up examinations put together).
- From II Year to III Year: For promotion to Third Year, a student should have (i) cleared all the Course Work requirements of I year and (ii) passed, with P or better Grade, at least 30 credits in II Year I Semester, Second Semester and make up examinations put together.
- From III Year to IV Year: For promotion to Fourth year, a student should have (i) cleared all the Course Work requirements of I Year, II Year and (ii) passed, with P or better Grade, at least 30 credits in III Year I Semester, II Semester and make up examinations put together.

Batch 2015 Onwards

There are no restrictions for promotion from odd semester to even semester, however restrictions are imposed for promotion from even to odd semester. These restrictions are as follows:



- From I Year to II Year: To be able to register in the third Semester, a student should have completed, with D or better grade, at least 30 credits at the end of first year (in first and second semesters and make up examinations put together).
- From II Year to III Year: For promotion to Third year, a student should have (i) Cleared all the Course Work requirements of First Year and (ii) passed, with D or better Grade, at least 30 credits at the end of second year (third Semester, fourth semester and make up





examinations put together).

6.0 TRAINING & PLACEMENT



On the day of farewell to final year B.Tech students, there were events of every club, competitions like






solo singing competition, dance competitions both solo as well as group..

• **KICKSTARTER DELTA**





9.0 CENTRAL FACILITIES AND SERVICES

9.1 Computer Center

The Computer Centre at NITD was established on 18th February, 2014 to cater the computational requirements of the Institute and is equipped with latest state of the art technological resources. The Institute visualizes centralized computing facility, campus wide networking and information technology as a means to enrich the educational experience and invigorate emerging areas of scholarly research and development.

The Computer Centre maintains and manages Wi-Fi facility through rack mounted blade servers in the campus having High speed (single mode) fiber

backbone, managed by Layer 4 Switches providing 275 Mbps (1:1) bandwidth Speed. These networking facilities are also extended to Boys Hostel, PG Girls and Residential areas with VoIP solution.

9.2 High Performance Computing Lab

NIT Delhi has established high computing Lab with workstations having INTEL XEON,SIX CORE processor. To meet high and computation needs for faculty and research scholar.

9.3 ParamShavak- Super Computing Facility

NIT Delhi has collaborated with the Centre for Development of Advanced Computing (C-DAC) to provide supercomputing solutions through the product PARAM SHAVAK. This is a Supercomputer in a Box solution, aims to provide computational resource (Capacity building) with advanced technologies to perform the high-end computations on a larger scale for the scientific, engineering and academic programmes.

9.4 Wi-Fi Enabled Campus





The campus and all the hostels of the Institute are fully WiFi enabled along with LAN facility. It is Single mode fiber (Point to point).

9.5 CCTV Surveillance




9.12 NIT Delhi IT Infrastructure Usage Policy

NIT Delhi endeavors to provide all faculty, students and staff with a modern, fully networked computing and IT environment for academic use.

Users of NITD computing, networking and IT facilities are expected to abide by the following rules, which are intended to preserve the utility and flexibility of the system, protect the privacy and work of students and faculty/staff, and preserve our right to access the international networks to which the system is connected. In case of complaints, appropriate action to be taken will be decided and taken by the person in-charge of the facility in consultation with the Director, Dean of Planning & Development, Dean of Students Welfare and

System Administrator as appropriate.

1. Faculty, staff, and students with authorized accounts may use the computing and IT facilities for academic purposes, official Institute business, and for personal purposes





so long as such use does not violate any law, Institute policy or IT act of the Government of India does not interfere with the performance of Institute duties or work of an academic nature (as judged by the NIT, Director) does not result in commercial gain or private profit other than that allowed by the Institute.

2. Users are expected to respect the privacy of other users and they may not allow any other person to use their password or share their account. It is the users' responsibility to protect their account from unauthorized use by changing passwords periodically and using passwords that are not easily guessed. Sharing of passwords for any purpose whatsoever is strictly prohibited. Users may share the required files through sharing software with proper ACL (Access control list).
3. Any attempt to circumvent system security, guess others' passwords, or in any way gain unauthorized access to local or network resources is forbidden. Users may not use another person's computing account, attempt to forge an account identity, or use a false account or e-mail address.
4. Transferring copyrighted materials to or from the NITD systems without express consent of the owner is a violation of international law. In addition, use of the internet for commercial gain or profit is not allowed from an educational site. If done so, it will be sole responsibility of the user.
5. Downloading and installing of new software has to be done with the explicit consent of the respective facility in-charges. Installation of unlicensed software on NITD facilities, or on individual machines connected to the NITD network, is strictly prohibited.
6. Setting up of any facility requiring password transmission over clear text is prohibited.
7. To the extent possible, users are expected to use only their official email addresses provided by NIT Delhi for official communications with other members of the Institute.
8. It is forbidden to use electronic mail and other network communications facilities to harass, offend, or annoy other users of the network, including impeding their computing systems, software, or data. Chain letters are not allowed. Neither is any form of commercial advertising, or soliciting allowed. Spamming is strictly disallowed. Subscribing to mailing lists outside the Institute is an individual's responsibility. Subscribing someone else to any group outside NIT Delhi is illegal.
9. It is forbidden to send frivolous or academically unimportant messages to any group. Broadcast of messages to everyone in the system is allowed only for academic purposes and emergencies. Violations of this (as decided by concerned authorities) will result in immediate freezing of user's account for an extended period as determined by the authorities.
10. Shared email accounts for any purpose whatsoever are not allowed. Any special accounts, if need to be set up for conferences and other valid reasons as determined by the institute authorities, must have a single designated user.



11. Recreational downloads and peer to peer connections for recreational purposes are banned.
12. To the extent possible, users are expected to connect only to the official NITD Wi-Fi network for wireless access. Setting up of unsecured Wi-Fi systems on the NITD network is prohibited in accordance with a Government of India ban.
13. Users are expected to take proper care of equipment, and are expected to report any malfunction to the staff on duty or to the in-charge of the facility. Users should not attempt to move, repair, reconfigure, modify, or attach external devices to the systems.
14. NO FOOD OR DRINK is permitted in the laboratories. Smoking is strictly prohibited. Also making noise either through games/ music or even talking and/ or singing loudly is prohibited.
15. Playing of Games in Institute laboratories or using Institute facilities is strictly prohibited. Internet chat is also banned.
16. Display of offensive material (either on computer screens or through posters etc.) is strictly disallowed and serious action will be taken against offenders.
17. Violations of policy will be treated as academic misconduct, misdemeanor, or indiscipline as appropriate. Depending upon the nature of the violation, the institute authorities may take an action by issuing a warning through disabling the account. In extreme cases, the account may be completely deleted and/ or the user prohibited access to IT facilities at NITD, and/ or sent to the Institute disciplinary action committee as constituted by the Institute authorities.
18. The policy may change as and when it is considered appropriate and new policies or the changes in policy will take effect immediately after a brief announcement by any means, e-mail, printed notices, or through the news groups.

Statement of Policy

All users of NIT, Delhi will be subject to the following

Acceptable Use Policy

1. **[Content]** I shall be responsible for all use of this network. In case I own a computer and decide to connect it to NIT, Delhi network, I will be responsible for all the content on it, especially that which I make available to other users. (This provision will also apply to any computer or device for which I am responsible, and is included in the meaning of “my computer”.) In case I do not own a computer but am provided some IT resources by NIT, Delhi, I will be held responsible for the content stored in the designated workspace allotted to me (examples: file storage area, web pages, stored/archived emails, on Computer Centre or Department machines).
2. **[Network]** I will be held responsible for all the network traffic generated by “my computer”. I understand that network capacity is a limited, shared resource. I agree that physically tampering with network connections/ equipment, sending disruptive signals, or making EXCESSIVE USE of network resources is strictly prohibited. Repeated offenses of this type could result in permanent disconnection of network services. I shall not share the network connection beyond my own use and will not act as a forwarder/ masquerader for anyone else.
3. **[Academic Use]** I understand that the IT infrastructure at NIT, Delhi is for academic use and I shall not use it for any commercial purpose or to host data services for other people or groups. Also, I shall not host or broadcast information that might harm others or may be otherwise considered objectionable or illegal as per Indian law.
4. **[Identity]** I shall not attempt to deceive others about my identity in electronic communications or network traffic. I will also not use NIT, Delhi IT resources to threaten, intimidate, or harass others.
5. **[Privacy]** I will not intrude on privacy of anyone. In particular I will not try to access computers (hacking), accounts, files, or information belonging to others without their




knowledge and explicit consent.

6. **[Monitoring]** I understand that the IT resources provided to me are subject to monitoring, with cause, as determined through consultation with the NIT, Delhi administration, when applicable. The monitoring may include aggregate bandwidth usage to effectively manage limited IT resources as well as monitoring traffic content in response to a legal or law enforcement request to do so. I authorize NIT, Delhi administration to perform network vulnerability and port scans on my systems, as needed, for protecting the overall integrity and efficiency of NIT, Delhi network.
7. **[Viruses]** I shall maintain my computer on this

network with current virus detection software and current updates of my operating system, and I shall attempt to keep my computer free from viruses, worms, Trojans, and other similar programs.

8. **[File Sharing]** I shall not use the IT infrastructure to engage in any form of illegal file sharing (examples: copyrighted material, obscene material). In particular, I have noted the following:







as single copies of articles as is done in the case of printed library material. Downloading or printing of a complete book or an entire issue or a volume of one or more journals (called systematic downloading) is strictly prohibited. Use of robots, spiders or intelligent agents to access, search and / or systematically download from the e-resources is also prohibited. Any violation of this policy will result in penal action as per the rules and regulations of the Institute. I am aware that Systematic downloading will result in the





publisher blocking the entire community of users at NIT, Delhi from accessing these resources.

9. **[Security]** I understand that I will not take any steps that endanger the security of the NIT, Delhi network. Specifically, I will not attempt to bypass firewalls and access rules in place. This includes not setting up servers of any kind (examples: web, mail, proxy) that are visible to the world outside the NIT, Delhi campus. In critical situations, NIT, Delhi authorities reserve the right to disconnect any device or disable any account if it believed that either is involved in compromising the information security of NIT Delhi.
10. **[Penalties]** I understand that any use of IT infrastructure at NIT Delhi that constitutes a violation of NIT Delhi Regulations could result in administrative or disciplinary procedures.

9.15 Library

Introduction: The Central Library, NITD was established in the year 2012 (10 June 2012) in Dwarka to facilitate the access to information resources to faculty and students of the Institute. It moved to its present location NILERD Campus, Narela Institutional Area on 18th February 2014. All the faculty members, students and staff of the Institute are entitled to access all the library facilities and services.

The library is growing rapidly with exponential increase in number and type of collection to serve the information needs of the clientele in the field of Engineering, Science & Technology. It has very good reading room facility with proper ventilation and natural lighting. Library has a rich collection in the field of Engineering and Science & Technology including mathematics, Physics, Chemistry, Polymer Science, and Environmental Sciences and also in the field of Humanities and Social Science including English and Economics.

Library Layout: The Central Library is housed on the first floor of the building with beautiful surroundings and is in midst of the campus which is easily accessible from all departments and hostels. It is just opposite to and very near to Computer Centre.

Library Hours: The Library remains open on all week days except Sunday. The visiting hours of library from Monday to Friday 9:30 am to 6:00 pm and on Saturday from 10:00 am to 4:00 pm with break of half an hour from 01:30 pm to 02:00 pm. The Library remain closed on Sundays and Gazetted Holidays.

Total Collection: The library has a total collection of approx. 12,852 volumes (approx. 1800 titles) inclusive of 3,414 books in Book Bank category. The collection includes the text books, reference

books and various competitive exams books. The total 1935 books are added to the library collection during the year 2015-16.

General Information

The library has nearly fifty-one book stacks including the reading area with adequate and comfortable seating arrangements. The reading and stack area is equipped with AC facility.

- The text books and reference books are arranged on the shelves subject-wise according to the Dewey Decimal Classification Scheme.
- The library follows Open Access System along with Self Check-in and Self-Check-out facility.
- Documents, belonging to 'Reference' category like Dictionaries, Directories, Handbooks, etc. are available for reference/consultation within the library premises only.
- The text books of the prescribed syllabus and other recommended books are kept in the Text Book collection along with separate reference collection for easy access to the users.
- The library subscribed 18 magazines (English/Hindi) during the year.
- The library also subscribes 09 (03 Hindi and 06 English) daily newspapers including one weekly newspaper.
- The Library provides "Email Alert Service" for the Circulation (Issue/Return), for sending Book Over-Due Alerts including notices etc. for various other activities of the library.
- The total number of books transacted (Check-out/check-in) to the users for reading/study purpose during the years 22,287 Nos.

Information Technology: Automated Library System

- The library is connected to the campus LAN and Wi-Fi facility. The library server works under Windows 8 environment.
- The Library uses LIBSYS 7 software package which is an integrated multi-user library



automation management system that supports all in-house activities of the library.

- The Library have RFID (Radio Frequency Identifier) based Automation system and Circulation system (self-Check-in/Check-out).
- The database of the entire library acquisitions is being updated on regular basis along with details of recently acquired books.
- The library has WebOPAC facility under which all the bibliographic details of the library collection can be accessed from Internet 24x7 on all week days by the users.

Library Membership

- All students, faculty members and staff of the Institute are eligible for the membership of the Institute library for using its facilities and services offered for the purpose of their academic, research and administrative work. Use of library facilities and services implies acceptance of its rules and procedures.
- General Text books are issued to all eligible members as per their entitlements.
- Documents, belonging to 'Reference' category, are not to be issued. Documents marked as 'Reference Copy' are to be consulted within the library premises.
- Reference books, Journals/Magazines, Standards/Patents, etc. are issued only to 'Faculty and Equivalent Staff Members' of the Institute.
- Membership privileges of a user may be suspended/cancelled as per the discretion of the Competent Authority/Librarian on account of misbehavior with the Library staff or for indecent manners/unscrupulous act.

General Resources & Services

- **Reference and Information Service:** The Library also has a collection of General reference books including Dictionaries, Handbooks, and





Bibliographies, etc. and these are available for reference within the library premises and are not for lending.

- **Resource Sharing:** There is Resource sharing facility for the users of the library to access the E-journals through J-Gate platform subscribed through NIT Consortium.
- **Document Delivery/Inter Library Loan:** Library provides document delivery service to the faculties and research scholars to support in their research and academic activities. Also if some document is not available in library, the same is lend through Inter Library Loan (DELNET) from the other Libraries. Library staff initiates to help their user regarding the information requirement of the user to fulfill their purpose/need of the urgent piece of information or document.
- **Internet:** Internet facility is provided centrally through Computer Centre.
- **Photocopy Facility:** Users are asked to avail the photocopy service for a specific piece of information. Copyright issues and Plagiarism is always taken care of by not allowing the excessive photocopy of a document.
- **Newspaper Clipping Service:** Newspaper clippings record about NIT's all over the India is maintained in the Library. Any other newspaper clipping required by the faculty or student on a specific heading is provided to them on request.
- **Book Bank:** The Library provides Book Bank facility to the B.Tech and M.Tech students. Under the Book Bank facility, the set of textbooks as

per the prescribed syllabus are issued to the individual student for entire semester.

- **CD/ROM Availability:** Library have 500+CDs/ DVDs of various Software's, EBooks, and Games etc. are made available to students and faculties as per their requirement. Also, there is a collection of CDs/DVDs in the library covering various subject areas like academic, entertainment, Information Technology and Competitive exams etc. Library have 500+ CD's including lecture video's, communication skills, CD's with text books, games, software etc. which are available for circulation of Users.
- **Audio-Visual:** A good collection of Educational videos (i.e. NPTEL video courses) are available for the users on varied subjects and are made accessible by the library.
- **Reading facility:** The library subscribed total 18 magazines (17 in English and 1 in Hindi) during the year on different subject areas like General awareness and Competitive, Science and Technology, Computer Sciences, Engineering, Sports and Health, Yearly GK magazines, Women awareness, Travel and Photography, etc. The library also subscribes 09 (3 Hindi and 6 English) newspapers including daily and weekly papers.

It provides seamless access to millions of journal articles available online offered by 13,202 Publishers. It presently has a massive database of journal literature, indexed from 44,704 e-journals with links to full text at publisher sites.
- **DELNET (Developing Library Network):** is a resource sharing network which provides access to various Union Catalogues and several Electronic Databases.
- **E-Library 'Mobile App':** The NIT Delhi has partnered with Knimbus to launch 'NIT Delhi eLibrary' which is India's first library mobile application for its students. The service offers a complete web-based service to manage the process of submitting and tracking papers electronically, providing better and faster feedback to students.

Library Advisory Committee: There is library advisory committee which consists of Chairperson and faculty members from each department including Assistant Librarian as the Convener. The library committee meets from time to time to frame and upgrade the policies and to review the working conditions for smooth functioning of the library.

Orientation Programme to Users: The library conducts orientation programme for the users from time to time whenever any new software/technology is introduced in the library for all the students, faculty and other staff members of the Institute for the maximum utilization of the varied library resources and services.

9.16 Hostels

There are four hostels available for students at different locations. Each hostel is provided with the following facilities: Mess, Gym, Indoor and outdoor game facilities, Television facility, Washing Machines, RO water supply.

We have audited the attached Balance Sheet of National Institute of Technology, Delhi as on 31 March 2016 and the Income & Expenditure Account/Receipts & Payment Account for the year ended on that date under Section 19 (2) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) Act, 1971. These financial statements are the responsibility of the management of National Institute of Technology, Delhi. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report contains the comments of the Comptroller and Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/CAG's Audit Reports separately.

3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4. Based on our audit, we report that:

i We have obtained all the information and explanations except fixed assets register, investment register and advance register, subject to the observations in the report, which to the best of our knowledge and belief were necessary for the purpose of our audit;

ii The Balance Sheet and Income & Expenditure Account/Receipts & Payments Account dealt with by this report have been drawn up in the format prescribed by the Ministry of Human Resource Development.

iii In our opinion, proper books of accounts and other relevant records except New Pension Scheme accounts was not attached to main Account, have been maintained by the Institute in so far as it appears from our examination of such books.

iv We further report that:

A. Balance Sheet

A.1 Liabilities

A.1.1 Current Liabilities & Provisions(Schedule 3) Rs. 18.99 crore .

The above do not include provisions for retirement benefits such as leave encashment and gratuity on the basis of actuarial valuation resulting in understatement of Current Liabilities & Provisions and overstatement of Capital Fund.

B. General

B.1 Schedule 10 pertaining to the Grants/subsidies has not been drawn. This is contravention of the format of Accounts prescribed by MHRD.

B.2 The accounts of New Pension Scheme was not attached to the main account.



B.3 Fixed Assets register, Investment Register and Advance registers were not shown to Audit.

C. Grants-in-aid

During the period 2015-16 the Institute received Plan grant of Rs. 15.00 crore from Ministry of Human Resource Development (inclusive of grant of Rs. 5.00 crore sanctioned in March 2015 out of which Rs. 0.85 crore was received in April 2016). It had an opening balance of grant-in-aid of Rs. 21.38 crore. Out of the total funds of Rs. 36.38 crore it utilized Rs. 22.84 crore leaving unutilised grant-in-aid of Rs. 13.54 crore as on 31/3/2016.

D. Management letter: Deficiencies which have not been included in the Audit Report have been brought to the notice of the Director, National Institute of Technology, Delhi through a management letter issued separately for remedial /corrective action.

v) Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income and Expenditure Account and Receipts and Payments Account dealt with by this report are in agreement with the books of accounts.

vi) In our opinion and to the best of our information and according to the explanations given to us, the said financial statements, read together with the Accounting Policies and Notes on Accounts, and subject to the significant matters stated above and other matters mentioned in Annexure to this Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India:

a. in so far as it relate to the Balance Sheet of the state of affairs of the National Institute of Technology, Delhi as at 31 March 2016; and

b. in so far as it relate to the Income and Expenditure Account of the surplus for the year ended on that date.
