Two Junior Research Fellowships (JRF) will be awarded under the Scheme for Copyright and IPR to the selected candidates according to the merit in the Entrance Test conducted by the NLIU subject to release of grant from the Ministry.

<u>Eligibility for Admission:</u> LL.M. Degree with at least 55% Marks in the aggregate. <u>Procedure for Admission:</u> All India Written Test and Interview.

Important Instructions

- 1. These instructions are in furtherance to the notification given for Admission to Ph. D. Program 2019-20 published in the newspaper and uploaded on <u>www.nliu.ac.in</u>.
- 2. The Admission to Ph. D. Programs shall be governed by the University Grants Commission (Minimum Standards and Procedure for award of M. Phil / Ph. D. Degree), Regulations 2009 and National Law Institute University Rules for Ph. D. Programs.
- 3. To be eligible for admission to Ph.D. Program, the candidate must secure at least 50% marks in the Entrance Test and Interview conducted by NLIU Bhopal However, the candidates who have qualified UGC NET/JRF *need not to appear in All India Written Test but will have to appear for interview before the Interview Board on the notified date*.
- 4. The Law Teachers of Indian Colleges / Universities may apply for admission to the Ph. D. Program 2019-20 with the prior approval of their Principal / Vice Chancellor. Such teachers if admitted to the Program will be required to stay in Bhopal for the duration of course work as notified by the university.
- 5. Every candidate admitted to the Ph.D. Program shall be required to stay in Bhopal for the duration of the course work as notified by the university.
- There are two types of Ph. D. Programs offered by the NLIU: First, a Ph. D. Program in any area of law including Intellectual Property Right without any fellowship.

Second, a Ph. D. Program exclusively in any area of Intellectual Property Rights Law with Research Fellowships as per the Scheme for Copyright and IPR subject to release of grant from the Ministry.

Kindly note that there are only two Junior Research Fellowships under the aforementioned schemes. The fellowships will be awarded to the selected candidates according to the merit in the Entrance Test (All India Written Test and Interview) conducted by the National Law Institute University, Bhopal subject to release of grant from the Ministry.

- 7. English shall be the language of written test, interview, course work, doctoral thesis and examination.
- 8. Kindly enclose, with the application form, the attested copies of all the mark sheets, certificates of examinations, degrees caste certificates, certificate of person with disability, and affidavit of intervening period, if applicable.
- 9. Fees including the application form fee (except the refundable fees) once deposited shall not be refunded under any circumstances whatsoever. The candidates must note this point before depositing the fees. The University reserves the right to revise the fee and charges from time to time.
- Please note that there are two copies of Admit Card. First is the 'candidate's copy' and the other is the 'office copy'. The candidate <u>must not</u> put his/her signature on the 'candidate's copy' for it is to be signed by him/her in the examination hall. The candidate <u>must</u> put his/her signature on the 'office copy' of the Admit Card.
- 11. There must not be any cutting, overwriting in the application form or admit card. In case the candidate has done any cutting or overwriting, he/she must download another form from the website of the NLIU and fill it afresh before submission.

- 12. The candidate must ensure that the application form must be received by the office of the Registrar, NLIU on or before May 17, 2019. The University shall not be liable for any delay on the part of the candidate, post office, courier service etc. in submitting the application form.
