## DRAFT ANNUAL REPORT OF MAHARASHTRA NATIONAL LAW UNIVERSITY, NAGPUR FROM APRIL 01, 2018 TO MARCH 31, 2019

#### 1. INTRODUCTION

The Annual Report was prepared by the Executive Council on working of the University in pursuance of the requirement as per Section 37 of the Maharashtra National Law University Act, 2014 for presentation before the General Council of the University for its consideration and approval as required by Section 14(3) of the Maharashtra National Law University Act, 2014. The period covered in this report is the financial year from April 01, 2018 to March 31, 2019. The University commenced its academic session on July 02, 2018, End Semester Examinations concluded on October 31, 2018, and result was declared on November 16, 2018. The next semester commenced on December 24, 2018. End Semester Examinations were scheduled from April 29, 2019 to May 03, 2019. During (winter) semester breaks, students went for the internships.

The Vice-Chancellor conducted a series of meetings on academic and infrastructural requirements with internal committees, faculty members and students as well as external agencies and government departments. The authorities of the University are also making best possible efforts to bring up state-of-the-art facilities at the University.

The University is empowered, *vide* letter no. F. 9-5/2017 (CPP-I/PU) dated June 14, 2017 by the University Grants Commission (UGC) under Section 2(f) of the University Grants Commission Act 1956, to award academic degrees as specified under Section 22 of the UGC Act.

The Governing Council of the Association of Indian Universities (AIU), *vide* letter no. Meet/GC/345 dated July 7, 2017, granted provisional membership of AIU to MNLU, Nagpur w.e.f., June 7, 2017 for three years extendable by two years, within which the University is required to fulfil the eligibility to obtain permanent membership after due inspection from AIU.

The University received an interim consent letter from the Bar Council of India, recognising MNLU, Nagpur to impart Five-Year Integrated Degree Course, B.A.LL.B.(Hons.) *vide* letter no. BCI;D;882/2018(LE/std. 22/23/24.6.2018) dated July 10, 2018.

Mr. Chamarti Ramesh Kumar OSD (Academics) was the Centre Observer for CLAT-2018 Examination Centre at Nagpur. The on-line examination was held in a very smooth manner. A total of 47,671 candidates appeared in CLAT 2018 for the Undergraduate Degree Course out of which 24,242 were Male, 23,428 were Female and 01 was Transgender. 117 (One Hundred Seventeen) candidates took admission in the University for B.A.LL.B.(Hons.) Five-Year Integrated Degree Course for the Academic Session 2018-23.

A total of 6793 candidates appeared for the CLAT 2018 Examination for Postgraduate Degree Programme, of which 3,125 were Male, 3,667 were Female, and 01 Transgender. 08 (Eight) students took admission in the University for One-Year LL.M. Postgraduate Degree Programme for the Academic Session 2018-19.

#### 5. CAMPUS DEVELOPMENT / INFRASTRUCTURE

#### 5.1. Present Campus

The University was functioning in Judicial Officers Training Institute (JOTI), Civil Lines, Nagpur until June, 2017. Thereafter, in the month of July 2017 the University was shifted to a hired building of 38,000 sq.ft. built-up area i.e. MORAJ Design and Decorators (DnD) Building, near Mihan Flyover Wardha Road, Khapri-Nagpur. The University being a residential University, hostel facility is provided to the students in MORAJ Waterfall Gateway Township, Mihan, Nagpur.

#### 5.2. Permanent Campus

The High Powered Committee headed by the Chief Secretary, Government of Maharashtra called for a meeting on January 20, 2018 at Mantralay, Mumbai to discuss about the Project Cost of the permanent campus of the University at Waranga, Nagpur. Prof. (Dr.) Vijender Kumar, Vice-Chancellor, Dr. N.M. Sakarkar, Registrar, Ar. P.S. Ahuja, University Consultant Architect and Ar. Manoj Ladhad, Partner, Architect Paradigm, Bangalore were present in the said meeting. A presentation on the proposed campus was made to the High Powered Committee.

The Hon'ble Shri Justice S.A. Bobde, Judge, Supreme Court of India, Chancellor of the University, called for a meeting with Hon'ble Shri Devendra Fadnavis, Chief Minister, Government of Maharashtra, Hon'ble Shri Nitin Gadkari, Minister, Ministry of Road Transport and Highways; Shipping and Water Resources and River Development and Ganga Rejuvenation, Government of India on January 28, 2018 to discuss about permanent campus of the University at Waranga, Nagpur. Hon'ble Shri Justice B.R. Gavai, Judge, Bombay High Court and Chairman, IDMC, Hon'ble Shri Justice R.C. Chavan, Former Judge, Bombay High Court and Member of IDMC, Shri Ashish Kumar Singh, Principle Secretary, PWD, Government of Maharashtra, Shri Sitaram Kunte, Principal Secretary, Higher and Technical Education, Government of Maharashtra, Shri N. Jamadar, Secretary Law and Judiciary Department, Government of Maharashtra, Ar. P.S. Ahuja, University Consultant Architect, Ar. Manoi Ladhad, Partner, Architect Paradigm, Bangalore were also present in the meeting. Further, Prof. (Dr.) Vijender Kumar, Vice-Chancellor, Dr. N.M. Sakarkar, Registrar and Prof. C. Ramesh Kumar, OSD (Academics) and Dy. Registrar were also present. The University Architect Manoj Ladhad from Architect Paradigm made a detailed presentation about the project.

The Infrastructure Development Monitoring Committee (IDMC) in its meeting held on January 12, 2019 has resolved that the necessary investigations including collection of baseline data for Environmental Impact Assessment (EIA) to be given to National Environmental Engineering Research Institute (NEERI), Nagpur towards the assessment of

the baseline status of Air, Water, Land and Biological components of Environment including Noise parameters of human interest covering one complete season. Further, the IDMC in its meeting held on January 12, 2019 resolved that water will be reserved from Wakeshwar Dam for the Permanent Campus of the University at Waranga. The IDMC in its meeting held on December 15, 2018 resolved that the issues common to three neighbouring educational institutions i.e. Maharashtra National Law University, Nagpur, Indian Institute of Information and Technology (IIIT), Nagpur and Kavikulaguru Kalidas Sanskrit University (KKSU), Nagpur can be taken together and the cost can be shared by these institutions. The IDMC of the University has appointed Visvesvaraya National Institute of Technology (VNIT), Nagpur for proof checking of design and drawings of RCC structures at the permanent campus.

The University has floated an Infrastructure tender through Office of the Executive Engineer, Public Works, Division No-I, Nagpur on 'E-procurement System', Government of Maharashtra on January 10, 2019 vide notice no. pwc/ngp/div1/92-01/2018-19 and e-tender no. 2019 PWR 397481 1 for Construction and Development Infrastructure facilities like Boundary Wall, Drainage, Road, Cable Ducts, Walk Way, Retaining Wall, STP, Nursery, Water Body, Side Development, Cross Drainage Works and Water Body connectivity etc. The value of the said Tender was Rs.23,06,55,083/- (Twenty-Three Crore Six Lakh Fifty-Five Thousand and Eighty-Three Only). The tender was opened on February 15, 2019 and the Work Order was given to Malani Construction Company, Malani Complex, 58-Kotecha Nagar, Kalavad Road, Rajkot-360001 Gujarat, India on March 7, 2019 who quoted an amount of Rs.19,87,04,148/- which is 13.85% below the estimated cost. The University has also floated a Tender through Office of Executive Engineer, Public Works Division No- I on Eprocurement System of Government of Maharashtra vide Notice no. pwc/ngp/div1/113-01/2018-19 and e-tender No 2019 PWR 407007 1 for Environmental Impact Assessment and Environmental Clearance from Ministry of Environment and Forests (MOEF) the value of the tender was Rs.14,34,000/- (Fourteen Lakh Thirty-Four Thousand only) and the tender was opened on February 11, 2019 and the Work Order was given to ABC Techno Labs India Pvt. Ltd., Chennai on March 9, 2019 who quoted 21.5% below the estimated cost i.e. Rs.11,25,690/- (Eleven Lakh Twenty-Five Thousand Six Hundred and Ninety Only).

#### 6.3. Ph.D. Degree Programme

#### 6.3.1. Batch of 2017

Maharashtra National Law University, Nagpur launched its Ph.D. Degree Programme in the year 2017. The Ph.D. programme is governed by the Maharashtra National Law University, Nagpur Ph.D. (Doctor of Philosophy) Regulations 2017. Thirteen (13) Research Scholars were provisionally registered to undertake the Ph.D. Course Work. These research scholars were selected based on their performance in the All India Admission Test held on August 13, 2017 and presentation of their tentative research proposal before the Research Committee comprising of eminent academicians. The research scholars had undergone the Course Work based on curriculum designed in accordance with the Ph.D. Regulations 2017. The Course Work curriculum was prepared by a committee nominated by the Vice-Chancellor and approved by the Research Committee in its meeting dated February 08, 2018. The Research Committee in the same meeting nominated Dr. Anirban Chakraborty, Associate Professor of Law, as the Coordinator of the Ph.D. Course Work 2018, responsible to oversee the smooth conduct of the Ph.D. Course Work in accordance with the directions of the Research Committee.

The period of taught classes in the Course Work was split into three clusters spread over the entire Semester period March 5-15, 2018; April 9-19, 2018 and May 07-18, 2018 respectively. There was an interval of three weeks between each cluster of taught classes where the research scholars were required to undertake various assignments under the supervision of their notional supervisors. The examination was held in the final cluster. The Research Committee meeting was held on July 24, 2018 wherein Eleven (11) Candidates were allowed for Final Registration into Ph.D. Degree Programme as per Maharashtra National Law University, Nagpur Ph.D. (Doctor of Philosophy) Regulations 2017 w.e.f. March 05, 2018.

#### 6.3.2. Batch of 2018

The University conducted All India Entrance Test (AIET)-2018 on September 23, 2018 at Nagpur Centre. A total of 50 applications (19 in the category of exempted and 31 in the category non-exempted applicants) were received. 30 candidates appeared for the AIET-2018 and 20 candidates successfully cleared the AIET-2018. Those candidates who cleared the AIET-2018 and those who were exempted (in total 39) were asked to submit the Preliminary Proposal. All the candidates were asked to appear before the Research Committee on November 13, 2018 for an interaction on the Preliminary Proposal.

The Research Committee met on November 13, 2018, wherein out of 39 candidates only 29 candidates appeared for the interaction and presentation of their Preliminary Proposal. After going through the Preliminary Proposals and the Presentations, the Research Committee asked the Candidates to submit a revised Preliminary Proposal after incorporating the suggestions.

The Research Committee after having due deliberations resolved to revise all the Preliminary Proposals and accordingly all the candidates were informed that they are required to send Revised Preliminary Proposals after incorporating the suggestions given by the Members of the Research Committee. The Research Committee met again on January 30, 2019, wherein only Twenty-Four (24) Candidates submitted the Revised Preliminary Proposal and the Research Committee unanimously resolved that out of Twenty-Four (24) Candidates only Sixteen (16) Candidates plus One (01) in Waiting List were declared suitable for Provisional Admission to the Ph.D. (Doctor of Philosophy) Degree Programme-2018.

#### 6.3.3. Orientation of Second Batch of Ph.D. Programme 2018





Maharashtra National Law University, Nagpur, organised Orientation Programme for Ph.D. Course Work for its 2<sup>nd</sup> Batch of Research Scholars on February 18, 2019. Padma Shri Prof. (Dr.) N.R. Madhava Menon, Hony. Professor and IBA Chair on Continuing Legal Education, NLSIU, Bangalore, inaugurated the Course. In his inaugural address, Prof. Menon emphasised that, research should be conducted in order to achieve justice in the light of constitutional goals such as social, economic and political justice. He also emphasised that the students should attempt empirical research to find out legal solutions for existing socio-legal problems. Prof. (Dr.) R. Venkata Rao, Vice-Chancellor, NLSIU, Bangalore who was also present at the Orientation Programme shared his thoughts and encouraged students to focus on new areas of research. The programme concluded with Vote of Thanks by Prof. C. Ramesh Kumar, Registrar (I/c) and OSD (Academics) of the University.
