

Library

The University has a gigantic seven storied Central Library building with all modern facilities including hi-speed wi-fi system. At present Central library possesses 37257 no of Books, 103 no of Journals and 262 e-Journal. A large number of Computer Terminal with high speed internet facility set up at the Central library. There will be dedicated cubicles and research room for Ph. D student and teachers. University Central library also contains collection of some of the rare books. At present University Journal Section is voluminous in very short span of time. Most of the Popular and important Journal at National and International level like Indian Journal.com, Oxford **EPW** Journal. Store, research foundations.



Cambridge Journal are now available in Central Library. Students can also access rich resources of National Digital Library, the vast e-content developed by National Knowledge Mission. An advance library software system is going to be arranged very shortly for open access the resources of library and search the catalogue of books and periodicals.

Verification of all original documents will be made at the time of counseling and only after document verification, she/he will be recommended for admission. If any short-listed candidate fails to produce her/his all original documents at the time of counseling, her/his candidature will be cancelled.

POLICY FOR ADMISSION TO POST GRADUATE COURSES ONLY

Out of the total seats in the respective department, 60% Seats are reserved for Home University category (for the students of Sidho-Kanho-Birsha University) and 40% seats are reserved for Other university category (for the students of other Universities).

Home University Category students who failed to get selection under Home University Category will also be considered in other university category.

Sports Persons who are participant in the State level /National level / Inter College/Inter University level tournament will get 5 % relaxation of the total marks for admission in any course.

Selection Process:

<u>For Home University Category:</u> Selection will be made strictly in order of merit by taking into consideration the marks in Honours / Major subject (UG).

<u>For Other University Category:</u> Selection will be made in order of merit. Merit list will be prepared by considering 50% of entrance test's marks & 50% in Hons/Major subjects marks.

In case of tie of Grade point, following will be considered.
